### LABORATORY TESTING RESULTS

**Test** : Fire Test, Ignitability of products by direct flame; BS 476-12.

Sample : Polyurethane Sandwich Panel (100 mm nominal thickness).

**Procedure:** Standard procedure of BS 476, Part 12 was applied on the received

polyurethane sandwich panel specimen from the client. Specimen was exposed to both surface and bottom edge ignition using direct flame for

40 seconds.

Results

The tested specimen was self-extinguishing.

No debris separation.
